How to Locate Items On Your Bill

- A. Account Number- This is a unique number assigned to each property. If you have questions, please reference this number when you contact our office.
- B. Prior Year Taxes Owed- If this message appears, back taxes are due. Contact the Tax Collector's Office at (850) 892-8121..
- C. Property Owner(s) and Mailing Address- Verify the ownership. If you have sold this property, forward the notice to the new owners or return the notice to the Tax Collector's Office. If your mailing address has changed, complete the address change form located under the forms section of our website and mail it or bring it to the Tax Collector's Office.
- D. Exemptions- If you have applied for and are approved for an exemption, a list will appear here. If any errors are found, please contact the Property Appraiser's Office immediately at (850) 892-8123.
- E. Total Taxes- No discounts have been subtracted from this amount. This is the amount due in March. If you look immediately to the left of this amount you will see the discounted amount if paid by the date listed above the amount. The payment must be received in our office by this date, not postmarked by the date.
